Full Terms and Conditions

- 1. Information provided by Ronald McDonald House Charities ACT & SE NSW on how to enter forms part of the terms and conditions of entry.
- 2. Purchase of a raffle ticket is deemed acceptance of these Terms and Conditions by the person whose name is either completed on the ticket or the person identified as a gift recipient.
- 3. Where a ticket in the competition is purchased as a gift for and/or on behalf of another person (gift recipient), the purchaser of the ticket is deemed to be acting as an agent for the gift recipient and the gift recipient will be deemed to have accepted these terms and conditions.
- 4. These terms and conditions apply to all entries into and/or prizes in the competition.

WHO CAN ENTER

- 6. Entry is open to all permanent residents of NSW, ACT and TAS, aged 18 years or older. WA, QLD, VIC and SA residents as well as purchasers external to Australia are not eligible to enter.
- 7. Employees, directors or officers of Ronald McDonald House Charities ACT & SE NSW, or agencies associated with this raffle, and their immediate families, are ineligible to purchase raffle tickets. Immediate families means a spouse or former spouse, de facto partner or former de facto partner, child, stepchild, parent, stepparent, grandparent, grandchild, sibling, or stepsibling of an employee of Ronald McDonald House Charities ACT & SE NSW.

HOW TO ENTER

- 8. Raffle ticket sales will commence on Saturday 26 July 2025 at 10:00am (AEST) and conclude on Saturday 18 April 2026 at 11:00pm (AEST) ("Promotion Period"), unless sold out prior. 9. A total of 10,000 tickets will be available for sale.
- 10. Each ticket costs \$20.

- 11. To enter, entrants must, during the Promotion Period:

- ii) provide their contact details (first name, last name, residential address, valid email address and mobile phone number) in the section provided.
- 12. Ronald McDonald House Charities ACT & SE NSW, will issue an e-ticket (which may be printed by the recipient) for online purchases or paper ticket for in-person or phone order tickets, for each ticket purchased, together with the ticket receipt.
- 13. No late entries will be accepted. Incomplete or incomprehensible entries will be ineligible.
- 14. Entrants are not restricted or limited to the number of raffle tickets which may be purchased during the Promotion Period.
- 15. To the extent permitted by law, without limiting the Non-Excludable Guarantees (defined in section 33) and subject to section 37), entrants cannot return any raffle tickets purchased or obtain a refund for the price paid on a raffle ticket, after the prize draw.

PRIZE

- 17. The prize is a Lexus LBX 2WD compact SUV, valued at \$53,390 AUD, including onroad costs and GST, from Lexus of Canberra (ABN 45 003 484 571). Prize value is the recommended retail value as provided by the supplier and is correct at time of publishing.
- 18. The prize includes on-road costs (stamp duty, 12 months registration and compulsory third-party insurance), as provided by our suppliers and is correct at the time of publishing. On road costs, duties and taxes vary per state the prize RRP is based on ACT.
- 19. The prize does not include comprehensive motor vehicle insurance. Ronald McDonald House Charities ACT & SE NSW strongly recommends that vehicle insurance

is purchased by the winner before the winner takes possession of the vehicle. All optional extras and accessories, and any other insurance not stated, fuel, personal costs and all other ancillary or related costs are not included.

- 20. The winner must collect the prize from Lexus of Canberra, 162 Melrose Dr, Phillip ACT 2606.

Entrants need not be present to win.
